4a (Code: ) (Expenses \$ 1,374,613. including grants of \$ ) (Revenue \$ 37,208. ) CLEAN WATER FOR PEOPLE: THE ALLIANCE FOR THE GREAT LAKES ADVOCATES FOR SAFE, CLEAN, AND ACCESSIBLE WATER FOR PEOPLE ACROSS THE REGION AND WORKS EXTENSIVELY WITH COMMUNITY GROUPS, GOVERNMENT AGENCIES AND ELECTED OFFICIALS TO SOLVE CLEAN WATER PROBLEMS. WE SUCCESSFULLY ADVANCED A FEDERAL POLICY AGENDA TO INCREASE FUNDING AND SHIFT POLICY TOWARD ELIMINATING DRINKING WATER CONTAMINANTS SUCH AS LEAD AND REBUILD THE INFRASTRUCTURE THAT CAN PREVENT SEWAGE OVERFLOWS. WE ALSO SECURED A DRAMATIC INCREASE IN FUNDING FOR THE GREAT LAKES RESTORATION INITIATIVE OVER THE NEXT FIVE YEARS, WHICH PROVIDES FOR CLEANUP OF CONTAMINATED SITES AND FISH AND WILDLIFE HABITAT RESTORATION. IN EARLY 2021, THE ALLIANCE RELEASED A SET OF TOP FIVE PRIORITIES FOR BOTH THE BIDEN ADMINISTRATION AND MEMBERS OF CONGRESS, HIGHLIGHTING THE
